

- The coronavirus pandemic






Vaccines, the Pandemic, the Economy, and Infrastructure Dominate Positive Conversation Around Biden This Week

With nearly three in four (71%) hearing "mostly positive" or an "equal mix," on Biden, majorities of Democrats (92%), independents (66%), and Republicans (50%) say the same.



Below is a list of issues. Please indicate who you trust more to handle:





And, which of the following best describes the current state of the U.S. economy:






Americans Still Split Between Confidence and Unease on Personal Finances






Support for the "American Rescue Plan" Remains Broad

More than three in five independents (61%) support the plan.






Younger Americans, Women, Independents, and Rural Americans Hearing Least About Stimulus

How much have you seen, read, or heard about President Biden and his emergency legislative package called the "American Rescue Plan"?






Making the American Rescue Plan's Child Tax Credit Expansion Permanent Is Broadly Popular

Nearly two in three Americans – and a majority of independents – support making the tax credit permanent.

One of the policies in the American Rescue Plan is expanding the child tax credit, or a tax cut for most families with children, for this tax year only. Below is a statement from supporters of the child tax credit who would like to make the tax credit permanent:

The American Rescue Plan included an expansion of the child tax credit for families with children, increasing the tax cut from \$2,000 to \$3,000-\$3,600 per child this tax year. Democrats say making this tax cut permanent would cut child poverty in the United States in half. The American Rescue Plan included an expansion of the child tax credit for families with children, increasing the tax cut from \$2,000 to \$3,000-\$3,600 per child this tax year. 


Strongest Argument on Child Tax Credit Permanence Is a "Tax Cut For Most Families With Children"

Net support is 7-points higher for making this "tax cut" permanent, rather than this "child tax credit" (+32 net support, compared to +25).




Support Remains Broad for "American Jobs Plan"

As you may know, President Biden has proposed the "American Jobs Plan." Do you support or oppose the "American Jobs Plan"?





Lowering Healthcare Costs and Middle Class Tax Cuts Enjoy Highest Support and Are Seen as Key Community Policies

Half of respondents were asked if they support or oppose a range of policies proposed by the Biden administration, while the other half was shown the same policies and asked whether each would help people in their community or not. Healthcare, tax cuts, and support for home health workers rose to the top on both.

About the Study

Global Strategy Group conducted public opinion surveys among a sample of 1,000 registered voters from May 6-May 10, 2021. 99 additional interviews were conducted among Hispanic voters. 96 additional interviews were conducted among Asian American and Pacific Islander voters. 102 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables.
