### **Key Takeaways:**




### Majorities Remain Pro-Choice and Say Abortion Should Be Legal

A majority of independents (63%) and nearly two in five Republicans (37%) say they are "pro-choice," and nearly three in four Americans believe abortion should be legal (72%); the share of independents who identify as pro-choice has increased by net 15 points since last April.

Which one of the following statements comes closest to describing how you feel about the issue of abortion?






### Three in Five Say Abortion Should Be Legal in All or Most Cases

Over the last year, the share of independents who say abortion should be legal in all or most cases has grown by net 21 points, from net +15 legal last April to net +36 today.

• Three in five independents (61%) and nearly two in five Republicans (38%) say abortion should be legal.

#### Which of the following comes closest to your position regarding the issue of abortion?






### Twice As Many Americans Say SCOTUS Overturning *Roe v.*Wade Has Been Bad for the Country Than Good

Independents believe the decision has been bad for the country by a 35-point margin (55% good for the country/20% bad for the country).

As you may know, the Supreme Court overturned *Roe v. Wade*, eliminating the federal right to an abortion as a result. Do you think the Supreme Court eliminating the federal right to an abortion has been good or bad for the country?





## A Nationwide Abortion Ban Is Deeply Unpopular; Congress Protecting the Right to an Abortion Is Broadly Supported

Two in three independents (68%) and roughly half of Republicans (49%) oppose a nationwide ban on abortion, while most independents support Congress guaranteeing the right to an abortion (net +28 support), as do 40% of Republicans.

• Both opposition to a ban and support for guaranteeing abortion rights have grown among independents and Republicans.




## Framing the Comstock Act as Archaic With an Explanation of Abortion Pill Circumstances Increases Opposition to a Ban


Providing context about anti-abortion advocates using the Comstock Act as justification for banning prescription abortion medication, the Act's antiquated nature, and the circumstances in which prescription abortion medication is mailed to patients to end an early pregnancy at home drives up opposition by net 13 points overall and by net 30 points among Democrats.




### More Americans Are Motivated to Vote Against Than For GOP Candidates Who Support Abortion Bans

More than one in four Americans say they are pro-choice and that a pro-abortion ban Republican would make them more motivated to vote, while just 15% of Americans are pro-life and say this kind of candidate would make them more motivated to vote.

• Nearly two in five Democrats (39%) and 35% of pro-choice Americans say this would make them much more motivated to vote.

If a Republican candidate running for office supported a nationwide abortion ban, would that make you feel more or less motivated to vote?






## Americans Describe Republicans Who Support a Nationwide Abortion Ban As "Extreme," "Out of Touch," "Dangerous"

Democrats and independents are most likely to describe Republicans who support a nationwide abortion ban as "extreme" (54% and 39%, respectively), "out of touch" (52% and 46%), and "dangerous" (57% and 40%).

• Republicans are most likely to say "conservative" (45%), followed by "traditional" (33%), "faithful" (30%), and "extreme" (28%).

About the Study

Global Strategy Group conducted public opinion surveys among a sample of 1,000 registered voters from June 14-June 20, 2023. 101 additional interviews were conducted among Hispanic voters. 75 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables.
