Student Loan Debt and the Economy: A Guide for Advocates

## **Majorities Support Alternative Loan Forgiveness Solutions**


Majorities of Americans who currently have student loan debt (+62 support), used to have student loan debt but do not have it anymore (+35), and have never had student loan debt (+24) resoundingly support Biden's alternative plans to provide student loan debt relief.

As you may know, the Supreme Court overturned President Biden's proposed student loan forgiveness plan – meaning, President Biden's student loan forgiveness plan will no longer go into effect. #### Since July, Fewer Blame SCOTUS and More Blame Congress for Failed Student Loan Forgiveness

Americans who currently have student loan debt are much more likely to blame the Supreme Court (41%) and Congress (38%) for why they are not getting student loan debt relief than President Biden (20%), loan companies (18%), or banks (7%).




#### Three in Four Remain Negative on National Economy, With Growing Unease in Personal Financial Situations

A majority of Democrats (54%), along with large majorities of independents (83%) and Republicans (93%), continue to rate the economy negatively, as Americans' confidence in their personal finances has declined since late August, especially among independents (net -40 confident now, down from net -22), Black Americans (net -18 vs. net +17), and AAPI Americans (net -14 vs. net +14).



#### Americans Feel They Are Paying More at Both the Grocery Store and at the Gas Pump

The share of Americans who say they are paying more at the pump has declined slightly since early August (78% now, down from 83%), driven mostly by Democrats (78% said they were paying more in August, 69% say the same now).

(Split sample) Thinking more about gas prices in your community... compared to a few weeks ago, would you say you're...





## Americans Blame Oil and Gas Companies, Foreign Conflicts, and Supply Chain Issues Most for Higher Gas Prices

Oil and gas companies are seen as most responsible by Democrats (78% top 3) and independents (66%), and second-most responsible by Republicans (49%). Independents also blame foreign conflicts (59%) and global supply chain issues (49%) most, while Republicans drive the share blaming Biden and Democrats (81%).

#### More Are Hearing About the Inflation Reduction Act Than in August, and Support Levels Remain High

Nearly half of Americans (48%) now report hearing "a lot" or "some" about the legislation, up from just two in five in August (41%); in 2024 Presidential battleground states\*, awareness has increased by 14 points since early August (from 35% "a lot"/"some" to 49%), with 68% of Americans in those states supporting the legislation.



## **Overwhelming Bipartisan Majorities Support Medicare Negotiating for Lower Prescription Drug Prices**


Huge majorities across party and racial lines support Medicare negotiating for lower prescription drug prices, with or without specific drugs.

#### About the Study

Global Strategy Group conducted public opinion surveys among a sample of 1,000 registered voters from September 7-September 11, 2023. 99 additional interviews were conducted among Hispanic voters. 73 additional interviews were conducted among Asian American and Pacific Islander voters. 105 additional interviews were conducted among African American voters. 99 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables.
