- Two in three Americans say it is important that Biden and Democrats take action to protect abortion access this year, including more than two in five who say it is "very important."





Two in Three Americans Are Pro-Choice and Three in Four Say the Government Should Stay Out of the Decision

Nearly half of Republicans (47%) say they are pro-choice, as do 64% of independents.

Majorities Say It Should Be Easier to Access Birth Control Pills, IVF, Abortion Pills, and In-Clinic Abortions

By wide margins, independents support making the elements of reproductive care tested easier to access.

• Majorities of Republicans support making birth control pills (net +56 easier) and fertility planning like IVF (net +43) easier to access, but they are more divided on the abortion pill (net -8) and in-clinic abortions (net -23).

Below is a list of items related to reproductive care. Please indicate whether you think it should be easier or more difficult for Americans to access each one.






About Four in Five Support Making Birth Control Accessible Without a Prescription and With No Out-of-Pocket Costs

Large majorities across party lines, gender, and age brackets support making birth control pills available over-the-counter and with no out-of-pocket costs to those with private health insurance.



About the Study

Global Strategy Group conducted public opinion surveys among a sample of 1,000 registered voters from February 15-February 19, 2024. 100 additional interviews were conducted among Hispanic voters. 75 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables.
