

Democrats and independents hold deeply negative views of oil and gas companies (net -39 and net -30 favorable, respectively), while Americans across party lines view Wall Street banks negatively.

A significantly greater share of Americans say they are paying more for gas than they were a few weeks ago (67%) than said the same in December (32%).

Thinking more about gas prices in your community... compared to a few weeks ago, would you say you're...






Oil and Gas Companies and Foreign Conflicts Most to Blame for Current Gas Prices

Few Americans blame environmental policies for current gas prices (just 27% say top two most to blame overall): Republicans drive the share who blame them (36%).

Please rank the following in terms of who or what you hold most responsible for current gas prices, 1 being the most to blame, and 5 being the least






Oil and Gas Companies More Blamed for Gas Prices Than Environmental Policies

Below is a list of some groups. Please indicate which three you think are most likely to be greedy and raise prices to make record profits.








Most Americans Feel the American Dream Is No Longer an Attainable Reality

About the Study

Global Strategy Group conducted a public opinion survey among a sample of 1,000 registered voters from April 18-April 22, 2024. 100 additional interviews were conducted among Hispanic voters. 75 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables.
