

Most Americans Report Hearing Negative Coverage About Trump in the Aftermath of His Felony Convictions

Nearly nine in ten Americans (89%) report hearing mostly negative or a mix of positive and negative news about Trump, including more than four in five across party and racial lines. Americans across party report hearing primarily about him being convicted on all 34 felony counts.

[If hearing negative/mixed news] In a few words, what negative things have you seen, read, or heard recently about Donald Trump?





Most Americans Report Following the News About Trump Being Found Guilty in Manhattan

Regardless of cable news network of choice, including Fox News, more than 80% are hearing "a lot" or "some" about Trump's conviction.

 Compared to awareness of other events in Navigator's tracking, Trump's conviction comes in higher than most events tested in the last couple of years like the collapse of Silicon Valley Bank in March of last year (59%), and the Chinese surveillance balloon being shot down last year (78%).

How much have you seen, read, or heard about Donald Trump being found guilty of falsifying business records in the Manhattan hush-money trial?





Roughly Two in Three Americans Say Trump Committed a Crime, the Highest Share in Navigator's Tracking

The 64% share who say Trump committed a crime as president is the highest share in Navigator's tracking – and 64% say Trump both "has committed a crime" more generally and more specifically, "committed a crime at any point as president."

• Large majorities of Democrats and independents, as well as one in three Republicans (34%), say Trump committed a crime.






Three in Five Say Trump Is Guilty, But Greater Division Exists on Whether He Should Go to Prison

Majorities of both independents (53%) and "double haters"* who are unfavorable to both Biden and Trump (59%) think Trump should go to prison in light of the verdict against him.







More Than Half of Americans Say Trump's Manhattan Trial Was Fair and Agree With the Verdict

Large majorities of "double haters"* say the Manhattan trial was fair (57% fair) and that they agree with the verdict (65% agree).



Majorities Say Trump Had a Fair Trial and Is Not Above the Law

Two in three Americans under 35 (67%) agree more that the trial was fair and not rigged, as do nearly seven in ten "double haters" ** (69%) and nearly two in three independents (63%).



A Majority of Americans Say Trump Should Drop Out in Light of the Verdict

More than two in three "double haters"* who are unfavorable to both Biden and Trump think he should drop out (66%), as do a majority of independents (51%).



Navigator is designed to act as a consistent, flexible, responsive tool to inform policy debates by conducting research and reliable guidance to inform allies, elected leaders, and the press. About the Study

Global Strategy Group conducted a public opinion survey among a sample of 1,000 registered voters from May 30-June 3, 2024. 100 additional interviews were conducted among Hispanic voters. 75 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among African American voters. 105 additional interviews were conducted among independent voters. 200 additional interviews were conducted among voters ages 18-34. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables. The margin of error for the full sample at the 95 percent level of confidence is +/- 3.1 percentage points. The margin for error for subgroups varies and is higher.
