## Americans Support Adding Sexual Orientation and Gender Identity to Federal Nondiscrimination Laws

Large majorities of Democrats (net +73 support) and independents (net +34 ) support adding sexual orientation and gender identity to federal nondiscrimination laws, as do more than two in five Republicans (42\% support).

## Almost Half Are Hearing About Anti-Trans Legislation

## Majorities Are Concerned About the Well-Being of the LGBTQ+ Community

Large majorities across party lines are concerned that LGBTQ+ youth are being bullied and targeted, ranging from 68\% of Republicans to $89 \%$ of Democrats.

## About Navigator

#### Abstract

About the Study Global Strategy Group conducted a public opinion survey among a sample of 1,000 registered voters from May 30-June 3, 2024. 100 additional interviews were conducted among Hispanic voters. 75 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among African American voters. 105 additional interviews were conducted among independent voters. 200 additional interviews were conducted among voters ages 18-34. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables. The margin of error for the full sample at the 95 percent level of confidence is +/- 3.1 percentage points. The margin for error for subgroups varies and is higher.
