Cuts and DOGE: A Guide for Advocates

- Three in five Americans are concerned about recent cuts to government programs.
- Americans are hearing a lot about and view negatively Elon Musk's involvement in the Trump administration and Trump's recent firing of government workers and attempts to close government agencies.
- When talking about cuts, the most troubling are the ones that directly impact Americans rather than those more focused on the bureaucracy. Of cuts Trump and Republicans have already done, the most troubling are related to health care, education, and safety. Of the policies they are proposing, the biggest worries are cuts to Social Security, Medicare, and Medicaid and higher costs due to tariffs.


- Musk and billionaires in the Trump administration acting like they are above the law, violating the Constitution and overriding government, and enriching themselves while harming the middle class and hurting the economy are seen as the most troubling descriptions of what they are doing.
- Spending cuts on their own are not a natural negative for Trump, and Americans trust him and Republicans more on government spending than they trust Democrats. Acknowledging there is waste in government that should be cut, while criticizing what Trump and Republicans have cut so far, helps bolster progressive arguments to win the spending debate.



Americans' Top Concerns: The Trump Administration Acting Like They Are Above the Law & Cutting Programs That Impact Them

Initial branding guidance on recent cuts under the Trump administration points to:


The Trump administration, led by (tech CEOs like Elon Musk and right-wing extremists), has already (cut programs with personal impact – health care and safety for women and children, veterans' health care, disease research, air traffic control, disaster relief, and education) and will (cut Social Security, Medicare, and Medicaid). They are (acting like they're above the law, overriding Congress and the Constitution, and enriching themselves) because they are (dangerous, power-hungry, and corrupt).



Three in Five Americans Are Concerned About Recent Cuts to Government Spending and Firings of Government Employees

Majorities of independents (63%) and 44% of 2024 Trump voters who do not strongly approve of the job he is doing are concerned.
Roughly four in five who know someone impacted by Trump's policies are concerned about cuts to the federal government.

As you may know, Donald Trump's administration has recently made significant cuts to federal government spending, including laying off thousands of federal government employees. How concerned are you about these cuts?*



Americans are most concerned about tech CEOs like Elon Musk (37%), right-wing extremists (31%), Project 2025 authors (29%), and billionaires (28%) being involved. Giving Musk Ownership of DOGE Drives Up Negative Views

Greater numbers of Democrats and 2024 Trump voters who do not strongly approve of the job he is doing are unfavorable to DOGE when Elon Musk is explicitly linked to it, while independents are slightly more favorable to DOGE when Musk is mentioned.





Musk's Involvement and Trump's Firings Viewed Most Negatively; Americans Are Mixed On Spending Cuts in Abstract

Elon Musk's involvement (net -12 feel more positively towards Trump) and Trump firing government workers and closing government agencies (net -11) make Americans feel more negatively; spending cuts without specifics make them feel more positively (net +6).






Acknowledging Waste in Government and Supporting Cutting Some Waste Helps Progressives in the Spending Debate

Americans, especially independents, are more likely to agree with a statement that acknowledges waste in government spending and supports some cuts (net +12), compared to a statement that solely criticizes Trump and Republicans for their spending cuts (net +4).

Which side do you agree with more?

Statement 1: The federal government has been bloated and wasteful for far too long. Right now, we have an opportunity to make big cuts to wasteful spending to right-size the government. We should make real change now, and we can always restore funding for important things later.

Statement 2: Everyone knows there is waste in government that should be cut, but Trump and Republicans are recklessly cutting critical programs that Americans rely on, without thinking about who it will hurt. Navigator is designed to act as a consistent, flexible, responsive tool to inform policy debates by conducting research and reliable guidance to inform allies, elected leaders, and the press. About the Study

Global Strategy Group conducted a public opinion survey among a sample of 1,000 registered voters from February 20-February 24, 2025. 100 additional interviews were conducted among Hispanic voters. 74 additional interviews were conducted among Asian American and Pacific Islander voters. 100 additional interviews were conducted among African American voters. 100 additional interviews were conducted among independent voters. The survey was conducted online, recruiting respondents from an opt-in online panel vendor. Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the national registered voter population across a variety of demographic variables. The margin of error for the full sample at the 95 percent level of confidence is +/- 3.1 percentage points. The margin of error for subgroups varies and is higher.
