Methodology



Impact Research conducted a survey of N=1,200 likely 2026 general election constituents in 62 battleground congressional districts (N=600) and seven battleground Senate states (N=600).



100% of interviews were conducted by text-to-web.



Interviews were conducted between February 10 - 17, 2026.



The margin of error for a sample of this size is +/- 2.7 percentage points at the 95% level of confidence. The margin of error for the House and Senate battlegrounds is +/- 4.0 percentage points and it varies for subgroups and is higher.

Key Takeaways

- Food and ag issues are important to battleground constituents, particularly cost and food safety. In fact, voters prioritize food safety higher than issues like lowering costs generally, and lowering specifically food costs outpaces voters' priority on border security – generally a top concern.
- The generic ballot is a toss-up. With nearly 20% of voters persuadable, battleground constituents living in the most competitive House districts and Senate battleground states are evenly split at 41% between Democrats and Republicans.
- While Democrats' biggest advantages on food and ag issues are related to making people healthier, food safety, and affordability, Republicans receive credit for working to get ultra-processed foods out of schools and supporting farmers.
- The food and agricultural policies tested are well-liked by battleground constituents, and they think the policies will be effective in making people healthier. Banning harmful chemicals from foods and crops, like banning Paraquat, are policies that rise to the top in both support and effectiveness.
- Cuts to SNAP, the continued use of dangerous pesticides, former industry execs leading the administration's policies, and the lack of funding for school lunches are the Trump and Republican actions that concern battleground constituents the most.
- Messaging on SNAP, the impact of America's food policies on kids, and cuts to food safety are key messages to drive home on Trump and Republicans' food and agricultural actions.








From what you know, are the Trump and Republican policies making Americans **more healthy**, **less healthy**, or making no difference?

Battleground Constituents Across The Board Think It's Extremely Important For Congress To Ban Paraquat – With No Partisan Gap.

As you may know, Paraquat is a pesticide that is linked to Parkinson's Disease and increased risk of kidney and thyroid cancer. It has been banned in over 70 countries, including the European Union and China where its parent company is based, but is still being used for farming in America where it affects workers and nearby residents. Accidents have also contaminated drinking water sources, forcing locals to purchase bottled water since it is highly poisonous.



Swing voters (persuadable voters and Independents) and Black voters shift the most.



Recommendations

Recommendations

- **Elevate food safety as a crucial way Trump and Republicans are endangering Americans' health and push for policies that emphasize getting harmful chemicals out of food – particularly pesticides like Paraquat. Right now, Trump and Republicans are ill-defined on health and receive some credit on certain food issues.**
- **Define Trump and Republicans as in the pocket of the food industry to describe both the motive for failing to make food safer, but also more expensive. Among voters who shift away from Trump, learning that he's installed food executives to regulate the food industry is deeply concerning and defines motive to not ban harmful chemicals. However corruption can be a deeper attack as voters believe food costs are high because of price gouging, and they are concerned about Trump allowing the food companies to consolidate and price gouge.**
- **Drive the SNAP cuts and impact on kids to define the active harm that Trump and Republican policies are currently causing. These are powerful examples of how Trump and Republicans have taken actions that harm the vulnerable.**

Message Framework

ELEVATE FOOD SAFETY

Trump and Republicans are putting Americans' health at risk by cutting funding for food safety inspections and have allowed the use of dangerous cancer-causing pesticides and chemicals in our food.

CONNECT TO CORRUPTION

Trump and Republicans have put food industry executives and lobbyists in charge of regulating the food companies. They have let food companies use dangerous chemicals to make our food less safe, and raise prices to increase their profits by driving out competition through creating loopholes and unfair monopolies that give them total price control.

DEFINE THE HARM

Trump and Republicans have cut food access for over 40 million Americans, including 16 million children and 8 million seniors, and made it harder for kids to get access to healthy foods, forcing them to rely on unhealthy ultra-processed foods.


When thinking about elections for Congress, are you more likely to vote for:


The Make America Healthy Again movement, also known as MAHA **Popularity**



Which of the following comes closer to your own view?



In your opinion, who is **MOST** to blame for the number of people who are unhealthy in America?



[PESTICIDES] Trump and Republicans have refused to ban certain dangerous pesticides, like Paraquat, that have been banned in over 70 countries and has been linked to Parkinson's disease.

[CORRUPT] Trump and Republicans have put former food and agriculture lobbyists and executives in charge of overseeing the country's food policies. This has led to the elimination of protections that keep food safe and has allowed food companies to price gouge customers.

[KIDS] Trump and Republicans failed to fund free school lunch programs that allow low-income children to receive at least one guaranteed meal a day.

[BIG FOOD] Trump and Republicans have given more power to the corporate food industry by giving them subsidies and decreasing regulations, allowing corporate consolidation with a few companies producing most of the food supply.

This has led to the elimination of protections that keep food safe and has allowed food companies to price gouge customers and sell food that is poisoning Americans. *

[TARIFFS] Trump and Republicans have imposed tariffs that have caused the prices of healthy foods like meat and produce to skyrocket. Since Trump and Republicans came into power, the cost of food has increased by nearly 3%, leaving people to cut down on buying healthy foods and turn to ultra-processed foods instead.

[DEPORTATIONS] Trump and Republican mass deportation policy has caused massive worker shortages throughout the food and agriculture industry leaving restaurants short-staffed across the country and affecting farm workers and staffing in food processing plants. This has caused the price of healthy food options in grocery stores to skyrocket with no end in sight.

[SICKNESS] The health care system is broken, and Americans are sicker now than at any other point in modern history. Trump and Republicans are making these problems worse by encouraging Americans to eat foods known to cause heart disease and colon cancer and allowing the food industry to make our food less safe with the use of cancer-causing chemicals.

[MISINFO] Trump and Republicans are spreading misinformation about health, food, and medicine that will cause people to make harmful decisions. By encouraging people to eat more red meat in order to be healthy, they are risking Americans' health.

About the Study

Impact Research conducted public opinion surveys among a sample of 1,500 likely 2026 general election voters from February 3-9, 2026. The survey was conducted by text-to-web (100 percent). Respondents were verified against a voter file and special care was taken to ensure the demographic composition of our sample matched that of the 62 congressional districts included in the sample across a variety of demographic variables. The margin of error for the full sample at the 95 percent level of confidence is +/- 2.5 percentage points. The margin for error for subgroups varies and is higher.
